

FREQUENTLY ASKED QUESTIONS (FAQs)

Q1. Who are eligible to seek admission in LL.B. (3 YDC) and LL.B. (5 YDC Integrated Courses) in the State of Telangana?

Ans: Candidates with any Graduation (with 10+2+3 pattern) or its equivalent and having 45% of marks (40% of marks in the case of SC/ST candidates) are eligible for seeking admission in 3 years LL.B. course, and candidates with Intermediate (with 10+2 pattern) or its equivalent and having 45% of marks (40% of marks in the case of SC/ST candidates) are eligible for seeking admission in 5 years integrated LL.B. course.(As per G.O. Ms. No.31 Dated. 18-3-2009) through TS LAW CET.

Q2. Is it necessary to qualify in the TSLAWCET to get admission into University, Government and Private Law Colleges in the State of Telangana?

Ans: **YES.** It is absolutely necessary for admission in University, Government colleges (in all seats). In affiliated Law Colleges in the State of Telangana, 80% of the seats are to be filled up exclusively with TSLAWCET qualified candidates (i.e., in the Convener's quota) and it is mandatory to qualify in the LAW CET examination of the concerned year for admission in the Convener quota. Admissions will be accorded as per rank obtained in lawcet.

Q3. Whether direct appearance in Graduation in one sitting without basic qualification i.e., Intermediate (or equivalent), will make the candidates eligible for seeking admission in LL.B. (3- YDC)

Ans: **NO.** The candidate must have passed his graduation in 10+2+3 pattern i.e. 10th class + 2 years Intermediate + 3 years Graduation, by securing minimum qualifying marks.

Q4. Whether ITI (Industrial Training Institute) certificate is treated as equivalent to Intermediate.

Ans: **No.** it is not recognized as equal to 2 years Intermediate. However, the candidate can submit Equivalent Certificate from the concerned authority to claim as equal to 2 Years Intermediate Course.

Q5. Whether the Polytechnic Diploma Holders are treated as having passed examination equivalent to Intermediate.

Ans: **YES.** In certain cases. Only the under mentioned Diploma Courses are equivalent to Intermediate.

A. Diploma in Electrical and Electronics Engineering

B. Diploma in Civil Engineering

C. Diploma in Mechanical Engineering

D. Diploma in Electronics and Communication Engineering

E. Diploma in Architecture and

F. D.D.A. Etc.

Q6. Are Engineering, Medical, Architecture, Pharmacy, and agriculture, etc. graduates eligible to seek admission in LL.B. (3 years) course?

Ans: **YES.** If they are treated as graduates by the concerned universities and Association of Indian Universities. (AIU)

Q7. Whether the candidates who pursued Intermediate from Telangana Open School (TOSS), Andhra Pradesh Open School (APOSS) and National Open School (NIOS) are treated on par with 2 years Intermediate Candidates.

Ans: **YES.** As per G.O. Ms. No.170 Dated.04.09.2010.

Q8. What are the 3 years and 5 years law degree courses offered in different law colleges in the State of Telangana State.

Ans: The list of the colleges and the law degree courses offered by them will be notified at the time of admissions.

Q9. Whether the candidates who pursued Degree from Open Universities or through distant education are eligible for seeking admission in to 3 year law course.

Ans: **YES.** But the candidate should have passed basic qualification, i.e. Tenth class plus Intermediate (10+2) and **three years study** of graduation through Open University or distance education.

Q10. Whether the candidates who have first completed graduation and then intermediate are eligible, for seeking admission in LL.B. (3-Years) courses.

Ans: **NO.** But they can appear for 5 years integrated law course on the basis of 10+2 (i.e. 10th class and Intermediate), if they have passed in such exams with stipulated minimum marks.

Q11. Whether the candidates who have pursued entire study in other states apart from Telangana State are eligible for seeking admission in to LL.B. courses with in Telangana State.

Ans: They may be considered in Non-Local quota/ NIQ (National Integration Quota), provided they should qualify in the TSLAWCET.

Q12. What is the qualifying examination?

Ans: For 3 years course, Graduation is qualifying examination, and
For 5 years course, Intermediate is qualifying examination.

Q13. What is the qualifying examination 'percentage of marks'?

Ans: For 3 years course, Graduation's percentage of marks.
For 5 years course, Intermediate's percentage of marks.

Q14. What is qualifying examination Hall Ticket Number?

Ans: For 3 year course, Graduation Hall Ticket No.
For 5 year course, Intermediate Hall Ticket No.

Q15. What are the gate way of payment of fee?

Ans: Debit cards / Credit Cards & Net banking.

Q16. Are Entrance Test centers available in other states of India?

Ans: Apart from Telangana, selected entrance test centers will be available in State of Andhra Pradesh only, and not in other States of India.

Q17. Can a candidate change the entrance test Centre?

Ans: **NO.** Once the Centre is allotted, it is final and no change will be entertained.

Q18. Is entrance test fee refundable in case the candidate wrongly pays the fee for LL.M. instead of LL.B. or for LL.B. 3 year course instead of LL.B. 5 year's course and vice-versa?

Ans: **NO.** Once fee is paid wrongly, it will be forfeited and will not be refunded.

Q19. Are the old dated certificates of Caste and Income etc., acceptable while filling the application form?

Ans: **NO.** Latest certificate Numbers should be filled in.

Q20. Is there any age restriction for applying for LAW CET and for admission in law courses thereafter?

Ans: There is no age limit for the academic year 2021-2022 (As per the BCI communication dated.26.11.2018)

Q21. Whether the students studied at unapproved study centers, off-campus centers, franchise institutions, colleges/institutions claiming to be affiliated with private universities or deemed universities are eligible for TS LAW CET.

Ans: **Not eligible.** See UGC Circular of 2013 (Vide No. DEB/QMC/2013 dated 23.8.2013) and also the decision of the TSCHE, Hyderabad dated 13th February 2021.

Q22. Whether Direct appearance in Graduation in one sitting by the candidates will make them eligible for seeking admission in LL. B 3YDC.

Ans: The candidates who have passed Degree examination by single sitting without undergoing three years of study either through regular or private or correspondence, those who obtained the degrees through Open University directly without having any basic qualification, and also those who obtained the degrees through external mode of Osmania University are not eligible. (See the judgement of the Hon'ble High Court, Hyderabad in W.P. No.23603 of 2019 dated 22.01.2021)

Q23. Whether TC is mandatory for taking admission in the Law course.

Ans: **Yes**, it is mandatory. Generally, the TC should be produced at the time of counselling or at the time of taking admission.

Q24. Whether LL. B. and LL. M. courses are available in Distance Mode in Telangana State?

Ans: No, there is no such provision.

Q25. Whether LL. M. courses through Private Appearance are offered in Telangana State?

Ans: No such courses are offered.
